

Contrary to what many people think, Medicare does not cover these long term care expenses.

As you take the very important step of assessing your future long term care needs, I encourage you to consider the benefits available through the Louisiana Long Term Care Partnership. In 2009, Louisiana's Department of Health and Hospitals collaborated with insurance companies and other stakeholders to ensure that Louisiana residents could purchase long term care insurance policies that can help address two major concerns: controlling your personal health care decisions and protecting your financial assets. Long term care insurance can help cover the cost of care at home or in residential facilities or nursing homes. It can also cover community-based services. Partnership policies allow you dollar for dollar asset protection should you ever need to apply for Medicaid services to cover the cost of long term care services.




